THE RULES

1. ALL VENDORS MUST SUPPLY THEIR OWN DISPLAY UNIT, INCLUDING TABLES CHAIRS, SHELVES AND CANOPIES - IF DESIRED. SPACE ASSIGNMENTS WILL BE DETERMINED BY THE COMMITTEE. EXHIBITORS' PREFERENCES WILL BE CONSIDERED. SPACE PROVIDED WILL BE 10' X 15'.

2. EXHIBITOR IS TO CONDUCT ALL ACTIVITIES WITHIN THEIR CONTRACTED SPACE. EXHIBITOR MUST KEEP BOOTHS OPEN DURING ENTIRE EVENT.

3. SET-UP IS SCHEDULED TO TAKE PLACE on Saturday June 29, 2024 10 am to 12 pm at POLAND VILLAGE HALL, 308 S. MAIN STREET IN POLAND. EACH EXHIBITOR IS RESPONSIBLE FOR SET-UP AND TEAR DOWN. TRASH RECEPTACLES WILL BE PROVIDED. ELECTRICITY IS **NOT** PROVIDED.

4. IT IS STRONGLY RECOMMENDED THAT EXHIBITORS CARRY THEIR OWN INSURANCE POLICY TO COVER THEIR ACTIONS. THE VILLAGE OF POLAND AND THE CELEBRATE POLAND COMMITTEE IS NOT RESPONSIBLE FOR LOSS OR DAMAGE TO EXHIBITORS OR VENDORS. **NOTE:** BY APPLYING TO EXHIBIT AT THE FESTIVAL, ALL EXHIBITORS AND THEIR PERSONNEL WAIVE ANY CLAIM AGAINST, AND AGREE TO HOLD HARMLESS, THE VILLAGE OF POLAND AND THE CELEBRATE POLAND COMMITTEE, AND THEIR EMPLOYEES, AND VOLUNTEERS, FROM ANY AND ALL LIABILITY FOR DAMAGES OR INJURY INCURRED DURING THE PARTICIPATION IN THE EVENT.

5. THE CELEBRATE POLAND COMMITTEE HAS A **ZERO** TOLERANCE POLICY, AND WILL BE STRICTLY ENFORCED. **NOTE:** POLICE WILL BE ON DUTY DURING THE FESTIVAL AND SET-UP/TEAR DOWN. THE VILLAGE OF POLAND AND THE CELEBRATE POLAND COMMITTEE ARE NOT RESPONSIBLE FOR INSURING EXHIBITORS' WORK OR DISPLAYS, AND CANNOT ACCEPT THE RESPONSIBILITY FOR THEFT OR DAMAGE. **SORRY, NO REFUNDS** ARE GIVEN FOR BAD WEATHER. ALL STATE GUIDELINES WILL BE FOLLOWED.
